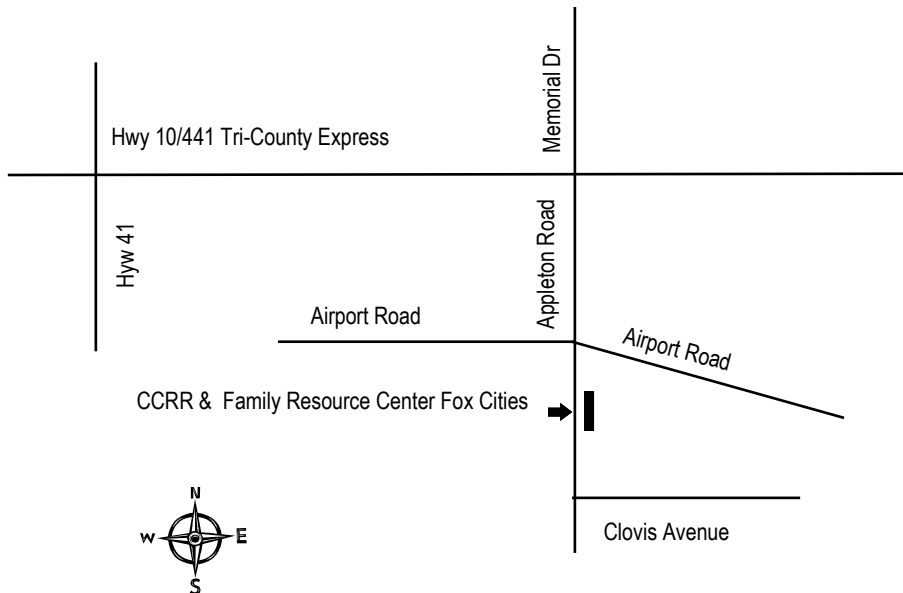
**Parking and entrance:** There is parking in the front and on the side of the building. The entrance is located in the front of the building .

**Directions:**

**From the west (Waupaca County):** Take Hwy. 10 east to Appleton. Continue on Hwy 10/441, take the Appleton Road/ Hwy 47 exit and turn right (south) onto Appleton Road. The office is located on the left side of the road (across from Affinity Occupational Health).

**From the east (Calumet County):** Take Hwy. 10 west to 441/10 west. Take the Appleton Road/ Hwy 47 exit and turn left (south) onto Appleton Road. The office is located on the left side of the road (across from Affinity Occupational Health).

**From the north or south:** Take Hwy 41 to Tri-County Express (Hwy 441 west). Exit on Appleton Road/ Hwy 47 and turn right (south) onto Appleton Road. The office is located on the left side of the road (across from Affinity Occupational Health).

## Levels of Child Care Regulation for the State of Wisconsin

**Provisional Family Child Care Provider:** may care for up to 3 children under age 7 and up to 3 children over age 7. SIDS and Shaken Baby Syndrome class are required. Infant and Child CPR is also required in some counties.

**Regular Certified Family Child Care Provider:** may care for up to 3 children under age 7 and up to 3 children over age 7. *Introduction to Family Child Care*, & *Fundamentals of Family Child Care* courses are required. Infant and Child CPR is also required in some counties.

**Licensed Family Child Care Provider:** may care for up to 8 children (actual number will depend on the number of children under age 2). *Introduction to the Child Care Profession* and *Fundamentals of Family Child Care* are required. If caring for children under the age of 2 years, *Fundamentals of Infant and Toddler Care* is also required. Infant and Child CPR is also required

## Frequently Asked Questions

How old must I be to provide regulated child care?

For any level of regulation, you must be 18 years old.

Do I need to take the SIDS Risk Reduction & Shaken Baby Syndrome (SBS) class?

Yes, Provisional Certified Providers must complete this training.

Do I need to take any additional classes? (Additional classes will include SIDS/SBS training)

If you wish to obtain a regular certificate or a state license, additional classes are required. (See above)

Who needs to have the background screening?

All residents in the home, age 10 or older, must have a background screening.

Do I need a fenced play yard?

Yes, a fenced play yard is required. This need not be your entire yard-you need 75 square feet of play space per child fenced in.

Do I need written policies?

Yes, all levels of regulation require written policies. Samples are available at CCR&R.

Am I eligible for payments through the Wisconsin Shares program?

All levels of regulation are eligible for payments through the Wisconsin Shares payment system. The amount of the payment will depend on your level of regulation.

Am I eligible for reimbursement through the Adult and Child Care Food Program?

All levels of regulation are eligible for reimbursement through the Food Program.
